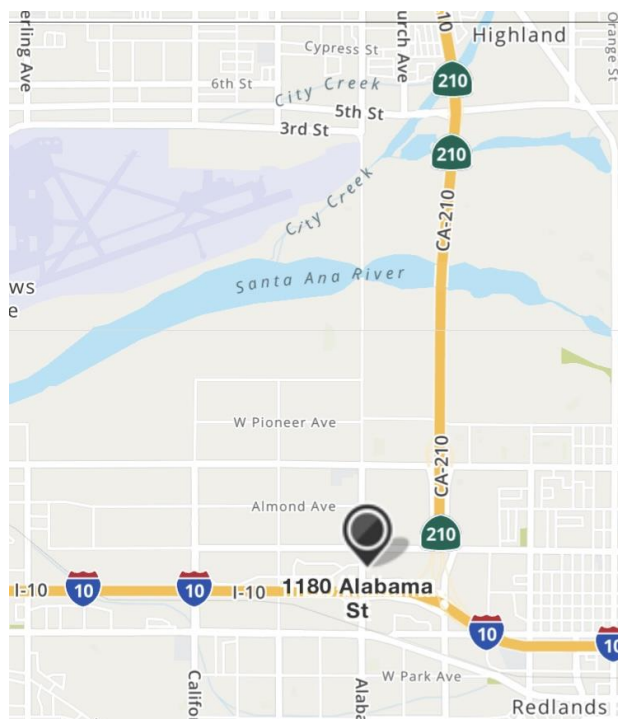
Meetings
